## 3.1 Mr Daryl Brown - Bennetts Road Christian Camp - 24 March 2015

**Question**: Are Council aware of what is happening at the Christian Camp on Bennetts Road? Mr Brown believes the Christian Camp is changing hands on Thursday 26 March 2015 and has been advertised as a possible 125 bay powered site Caravan Park. The residents of Bennetts Road are concerned about pollution, waste, potable water, increased traffic noise, trespassers and off road bikes.

## **Response from Shire Planner:**

The original planning approval was for a church retreat facility only. I am of the opinion that any new commercial caravan park venture will need to re-apply for planning approval.

Myself and Tim Jurmann did a site visit on Monday 20<sup>th</sup> April, and the new owners whom we met on site did confirm that they are in the process to clean up the property and getting rid of most of the caravans. It is apparently their intention to only live on the block and not have a commercial caravan park facility. Mention was made to retain some of the existing cabins as accommodation for visiting family and friends, but not commercial in nature.

The new owner of the land is involved with off-road racing and did mention that an event might be held on the property in due course. I did inform him of the requirements to apply to the Shire for permission to be able to do so, and he acknowledged as such.

We have also requested that they be in contact with the Shire in regards to any new developments planned for the property, so that we can advise as to the statutory requirements in terms of Planning & Building permissions.

## **SUMMARY**

An application for a special event on Lot 83 Butchers Road, Westdale – the Turner Gully Dirt Drags, had been received from One Twenty One Racing. The application will be recommended for approval.

## **BACKGROUND**

It is proposed to conduct the Turner Gully Dirt Drags on the following dates:

- 16<sup>th</sup> May 2015
- 14<sup>th</sup> May 2016
- 13<sup>th</sup> May 2017; and
- 12<sup>th</sup> May 2018,

The subject site (Lot 83 Butchers Road, Westdale), is approximately 49 ha in area, zoned Farming and contains existing buildings.

It is anticipated approximately 500 persons will attend the event. Similar events have taken place on the same subject property in the past.

## **COMMENT**

Under the Shire of Beverley's Town Planning Scheme No. 2 (TPS 2) the proposed event is a *use not listed*. Clause 3.2.5 of TPS 2 states that where a land use is not listed Council may:

- a) Determine that the use is not consistent with the objectives and purposes of the particular zone and is therefore not permitted; or
- b) Determine by absolute majority that the proposed use may be consistent with the objectives and purpose of the zone and thereafter follow the advertising procedures of Clause 6.2 in considering an application for planning consent, following which Council may, at its discretion, permit the use.

In previous years the event has attracted a substantial number of tourists, members of the travelling public and residents of Beverley.

Given that the proposed use will not preclude agricultural use of the property for the remainder of the year and provides entertainment options not normally available in

Beverley, it will be recommended Council determine that the proposed use may be consistent with the objectives and purpose of the Farming zone.

## **Advertising**

In compliance with Clause 6.2 of TPS 2 the application was advertised for a period of 21 days. A total of 2 submissions were received, none comprising any objection to the event. A summary of the submissions received and officer's responses are detailed in the table below:

Similar events have occurred on this property previously. A search of Shire records indicates no correspondence regarding serious matters of concern has been received by the Shire.

The event will aid in economic development and economic diversification in the Shire of Beverley. Direct economic enhancement will occur due to catering for the needs of the substantial number of persons attending the event. Indirect economic benefit will come from raising the profile of Beverley throughout the state and making Beverley a tourist destination. As such the event will aid in economic diversification in Beverley.

Entertainment options in Beverley may be considered limited for the younger age groups. This event will provide an entertainment option comparable with those in the metropolitan area and not generally available in Beverley. As such the event will aid in enhancing the amenity of the Shire.

## **Fire Management**

The proposal contains a fire management plan and an emergency evacuation plan to be implemented for the duration of the event. Should Council approve the application it will be recommended the fire management and emergency evacuation plans be implemented as conditions of approval.

## First Aid and Management Plans

As components of the application, a fire risk, precaution and evacuation plan and a traffic management plan have been submitted. To cater for first aid at the previous events, an ambulance and three staff were on duty during the duration of the event. Shire staff consider similar first aid arrangements should occur from 8.00 am to 9.00 pm on 17 May 2015. Should Council approve the application, it will be

recommended the fire and traffic management plans and first aid arrangements as detailed, be specified as conditions of approval.

## Conclusion

The application to conduct the Turner Gully Dirt Drags at Lot 83 Butchers Road, Westdale is supported due to:

- 1. Diversification of economic activity;
- 2. Enhancement of amenity through provision of generally unavailable entertainment options:
- 3. Raising the profile of the Shire of Beverley;
- 4. No objections to the proposal; and
- 5. Economic benefit to the local economy.

It will therefore be recommended the proposal be considered a land use that is consistent with the objectives of the Farming zone and Council grant planning approval.

## STATUTORY ENVIRONMENT

Subject to Council determination by absolute majority, as discussed above, the application may be considered consistent with the Shire of Beverley's Town Planning Scheme No. 2.

## TURNER GULLY DIRT DRAGS

## 2015

## **EVENT OVERVIEW**

Due to the continued interest within the 'Off Road' sporting community and continuing success of similar events throughout Australia, ONE TWENTY ONE RACING seeks the opportunity to stage TURNER GULLY DIRT DRAGS 2015 and subsequent annual events up to and including 2018.

TURNER GULLY DIRT DRAGS is a proposed Test and Tune event designed to allow local and interstate competitors, in all age brackets, the opportunity to demonstrate and/or tune their machines within this controlled, purpose built, ¼ mile venue. This venue has been designed to National Standards with state of the art electronic timing equipment and as such is the benchmark in Western Australia for this type of event. The proposal also includes a Burn-Out demonstration (to be confirmed)

The proposed TURNER GULLY DIRT DRAGS is to be held on a portion of 49ha of private land located at Lot 83 'Dale' in the Shire of Beverly over the periods :  $16^{th}$  May 2015 /  $14^{th}$  May 2016 /  $13^{th}$  May 2017 /  $12^{th}$  May 2018 between the hours of 9.00am to 7.00 pm.

Organisers expect a patronage of around 500 persons to attend the events. Public parking and overnight camping areas have been provided.

Cool drinks and water will be made available during these events.

## FIRE RISK

The expected fire risk at the time of each event is considered negligible due to seasonal change within that period and the date of the events fall outside the 'fire ban' period. The area designated for use within the property boundaries consists of gently undulating pasture with small hills and ridges interspersed with smooth stone outcrops. There are few trees within the designated area until it meets the rising eastern boundary which is lined with low scrub and gum.

## FIRE PRECAUTIONS

ONE TWENTY ONE RACING will designate approximately 6 – 8 event staff as Safety/Fire Marshalls and they will be provided with two-way radios and have all terrain mobility.

Licensed security officers and associated personnel provided by Astute Security Services will be on duty throughout the events and all will be designated 'Safety/Fire Marshalls'. They will be equipped with 2-way radios and distinctive clothing and will have attended a briefing prior to the event.

ONE TWENTY ONE RACING will establish a liaison with Emergency Services to enable correct and appropriate response to any critical incident.

Water from the dam and tank system will be utilized by the organiser by means of water pumps and mobile water carts (trucks).

A water tanker and delivery system will be on standby at the property in the event that it is required. However, in the likelihood of a major fire situation it is anticipated that an evacuation will be conducted and the incident to be handled by FESA/CFA.

Any bulk fuel brought by competition entrants will be stored in a stand-alone area adjacent to the dirt drag pit area and access will be restricted.

Fire extinguishers will be located in strategic areas on the venue site – especially in areas of structure and high risk.

A site inspection will be conducted in the week preceding the event to reevaluate any potential fire risk.


Professional and volunteer St. Johns Ambulance First Aid personnel will also be on-site to attend to any medical emergencies.


## EMERGENCY EVACUATION


If any situation occurs that is deemed by the organisers to have the potential to threaten the safety of event staff and patrons a general evacuation of the site will be called. This will involve the use of the Public Address System to announce a General Evacuation and Fire Marshalls with loud hailers will direct persons away from the point of any danger to the designated Evacuation Assembly Point. In case of evacuation the route will be by way of the main access road and persons will be mustered outside the main gate toward Butchers Road (west). This route will be familiar to all persons who have entered the property. If necessary an alternative or extra route may be accessed through the public parking area. Attempts to evacuate vehicles and possessions WILL NOT BE PERMITTED until such time that any potential danger has been deemed safe by attending Emergency Services. The property is bounded by standard wire fencing and specific areas within the event area will be fenced off. However, these fences will be of low-level, light construction and are not considered a 'containment' threat in the case of an evacuation.

We envisage all agencies will work well together to achieve a safe, enjoyable and successful event.





## **SUMMARY**

Amendment 23 to Shire of Beverley Town Planning Scheme No. 2 is presented to Council for final adoption. It will be recommended the request be approved.

## **BACKGROUND**

At its 25 November 2014 meeting Council resolved to initiate Amendment 23 to Shire of Beverley Town Planning Scheme No. 2 to enable development of the Beverley Multi-Purpose Community Centre on Shire owned land. For reference please refer to the attached Scheme Report.

## COMMENT

At the abovementioned meeting the Shire Planner was further instructed to forward the documentation (Scheme Report) to the Environmental Protection Authority (EPA) for assessment and the Western Australian Planning Commission (WAPC) for information.

Following a determination from the EPA under section 48A(1)(a) of the *Environmental Protection Act 1986* that the Scheme Amendment should not be assessed under Part IV Division 3 of the Act, Shire Planner proceeded to advertise the Scheme Amendment, as prescribed by and in compliance with the *Town Planning Regulations 1967*.

No objections were recorded during the consultations that were had, as detailed in the table hereunder, and the request for final adoption will be recommended for approval.

## **CONSULTATION**

In compliance with the *Town Planning Regulations 1967* the proposal was advertised for a period of 42 days. Affected Land owners were notified by mail. A copy of the relevant Scheme Amendment documentation was available on the Shire's website, as well as the front counter of the Shire Administration Office. A copy was also displayed on the Official Shire Notice Board. A total of 3 submissions were received. The submissions and Shire Planner's responses are presented in the table below for Council's consideration. Should Councillors so wish, copies of the submissions can be made available on request.

## The following conventions, as per WAPC guidelines are used in the table:

All submissions are 'noted' however the terminology of 'Dismiss, 'Upheld' or 'Partially Upheld' is standardized for recommendations to the WAPC. If a submission is only 'noted' it does not make it clear to the WAPC whether Council agrees or does not agree with the submission. If a submission is 'upheld' it means that Council agrees that the amendment should be modified as a result of the submission. If a submission is 'dismissed' it means that no modifications are recommended.

If Telstra's facilities are damaged as a result of any property development or any interference with such facilities, the person will be liable in tort (negligence) for any loss or damage (including consequential loss) suffered by Telstra and/or any member of the public. Telstra will not hesitate to take action to recover such loss or damage caused by such interference to Telstra's Network.

## **SUMMARY**

Council to consider receiving the "Infrastructure and Services Audit Report" for the Shire's of Beverley, Brookton and Pingelly as provided by Verso Consulting.

## **BACKGROUND**

The Shire of Beverley signed an agreement with the Shires of Brookton and Pingelly to form an alliance to address future Aged Care and Support Solutions in all three Shires (commonly known as the BBP). The BBP engaged the services of Verso Consulting to undertake an Infrastructure, Services and Facilities Audit.

# **COMMENT**

Council's delegates on the BBP Committee sought comments from the Economic and Community Strategy Committee in relation to recommendations in the Infrastructure and Services Audit Report as provided by Verso.

At the Economic and Community Strategy Committee Meeting on 14 April 2015, it was the general opinion of members to go forward with the BBP, providing it not be to the detriment of Beverley and its current facilities. It was resolved to receive the report.

A summary of the recommendations made within the report include:

- Consolidating the current residential aged care for the BBP into the Kalkarni Residency by supporting planning and expansion of the Kalkarni Residence, building at least 25 additional beds by 2021 and a further 10 to 15 by 2026.
- Deliver an alternative to Residential Aged Care. (Cluster Housing)
- Considering an alternate use for the Beverley Lodge.
- The BBP Aged Care Partnership should operate a range of aged care and carer services as included in the Commonwealth Home Support Program.
- To secure the delivery of a full range of packages. (Level 1 through to Level 4).
- Development of Modular Housing within walking distance of the towns existing service areas.

- Continue conducting ongoing Age Friendly Audits.
- Develop a "Pathway Plan" in each town.
- Develop a joint coordination and improvement approach to community transport for the BBP Aged Care Area.
- Establish community advisory committees.

Verso believes by putting these recommendations in place, this will enable the BBP Aged Care Partnership to improve the wellbeing of their residents. In time it will also offer the continuum of care for older residents residing within the partnership boundaries, allowing them to remain in their town which has been a strong desire of residents. This was, outlined in a survey conducted in Beverley in 2012, where 94.9% of respondents stated their preference to remain in Beverley.

Also contained within the report, Beverley has the greatest 55yrs+ and 70yrs+ current and projected age population (page 9 and 10) within the BBP. There has also been a comment made that the Beverley Hospital becomes a primary health care site.

With the Beverley Hospital due to undergo significant renovations in 2015/16 I believe caution would be required for any consideration to alter the current structure of Aged Care within Beverley as it could well be detrimental to retention of the services currently provided.

## **SUMMARY**

#### **BACKGROUND**

The Shire of Beverley has been the custodian of the machinery museum since 2009 but has so far failed to successfully progress the cataloguing of museum items in a timely manner. Council has previously indicated that the machinery is of historical value and importance but an accurate record of all inventory and proper interpretation is lacking. The Avondale Farm Project Association (AFPA), with the assistance of Mr Greg Manzies has recently begun recording the machinery.

Mr Manzies made a presentation to the Economic & Community Strategy Committee to showcase the work that he and Mr John Pratt along with other AFPA representatives have done in developing a database on the machinery using Filemaker Pro.

#### COMMENT

To further progress the museum, compliment the volunteer work being undertaken by AFPA and to secure the services of Mr Manzies, it is proposed to offer him the position of Honorary Museum Director of the Avondale Collection and contribute \$5,200.00 to this position. The honorarium to be paid quarterly in arrears.

The position of Honorary Museum Director of the Avondale Collection will report directly to the Chief Executive Officer and will be required to submit a quarterly report Council.

The Museum Director will be responsible for:

- 1. Overseeing the completion of the machinery museum database;
- 2. Assisting with development of an MOU between the Shire of Beverley and AFPA;
- 3. Developing a strategic plan for the machinery museum; and
- 4. Communicating on the progress of the database and museum development to the Shire of Beverley.

AFPA member Mr John Pratt, who works closely with Mr Manzies, has been consulted to avoid any resentment within the group and agrees this would be a valuable appointment.

I would also be recommending that the position be reviewed again in 12 months.

As a side note, the position will be of considerable use if Council is successful with the grant application for the proposed Multipurpose Community Centre which includes a "museum taster" within the new building.

#### COMMENT

The Lease agreement states under section:

10. Co-location Assignment and Sub-Letting:

#### 10.2 No Assignment, Transfer, etc.

'Except as set out in this clause 10, the Lessee shall not assign, transfer, sub-let or part with possession of the Premises or any part thereof or permit the Premises or any part thereof to be assigned, transferred, sub-let or put into possession of any person or persons without the consent of the Lessor and if such consent is granted then on such terms as the Lessor shall reasonably determine.

Sections 80 and 82 of the Property Law Act are excluded and do not apply to this Lease.

## 10.3 Not to Mortgage or Charge

The Lessee shall not mortgage, charge or otherwise encumber any estate or interest in the Premises or any fixtures fittings or equipment on the Premises without first obtaining the consent in writing of the Lessor.'

The letter from Beverley CRC states that CBH is looking to set up an office for one staff member in Beverley on a lease contract.

## **SUMMARY**

#### **BACKGROUND**

The Australian Local Government Association (ALGA) and State Local Government Associations are seeking the support of Council to have the Federal Government reverse the decision to freeze the indexation of FAGs.

## COMMENT

The Federal Governments decision in the 2014 Federal Budget to freeze the indexation of FAGs for three years beginning in 2014-15 will unfortunately cost councils across Australia an estimated \$925 million by 2017/18.

FAGs are a vital part of the revenue base of all councils, and this year councils will receive \$2.3 billion from the Australian Government under this important program.

There is no doubt that a freeze on the indexation of the FAGs would affect Council's funding in the vicinity of \$170,000.00 to \$200,000.00 over the 3 years.

Council will be receiving \$1,335,936.00 in 2014 / 2015, this is broken into three areas namely General Purpose Funding \$819,474.00, Road Funding \$456,462.00 and Special Bridges Funding \$60,000.00.

While the FAGs are paid through each states Local Government Grants Commission, the funding originates with the Commonwealth and it is important it is recognised as such. Council, and every other Council in Australia, have been asked to pass a resolution acknowledging the importance of the Commonwealth's Financial Assistance Grants in assisting Council to provide important community infrastructure.

Council is also being asked to acknowledge the receipt of Financial Assistance Grants from the Commonwealth in media releases and council publications, including our annual report.
