#### SUMMARY

#### BACKGROUND

There is a statutory requirement that the Local Government is to prepare, each month, a statement of financial activity reporting on sources and applications of its funds and to present the statement to Council.

#### STATUTORY ENVIRONMENT

Section 6.4(1) of the *Local Government Act* provides that a local government is to prepare an annual financial report for the preceding financial year and such other financial reports as are prescribed.

Regulation 34 of the *Local Government (Financial Management) Regulations* requires a Statement of Financial Activity to be prepared each month which is to contain the following details:

- (a) annual budget estimates;
- (b) budget estimates to the end of the month;
- (c) actual amount of expenditure and revenue;
- (d) material variances between comparable amounts in (b) and (c) above; and
- (e) the net current assets at the end of the month to which the statement relates (i.e. surplus / (deficit) position).

The Statement is to be accompanied by:

- (a) explanation of the composition of net current assets, less committed assets and restricted assets;
- (b) explanation of the material variances; and
- (c) such other information considered relevant by the local government.

- (a) presented to the Council at the next ordinary meeting of the council after the list is prepared; and
- (b) recorded in the minutes of that meeting.

#### SUMMARY

Council to consider offering Elmline Pty Ltd a lease for Reserve 25266 after Waterbrae Pastoral Company declined the lease agreement.

#### BACKGROUND

At the 28 June 2017 Cropping Committee Meeting, the committee resolved to call for submissions for the Community Cropping leases.

The submission received for Reserve 25266 Bethany Farm for \$2,300.00 was significantly lower than previous awarded leases and did not cover the Shire's annual lease rental payment to the Department of Lands, which was \$5,000.00 per annum ex GST.

At the 24 October 2017 Council meeting it was resolved;

- 1. re-advertise the lease for Reserve 25266 for two weeks in the November Blarney for awarding at the Ordinary November Council Meeting; and
- 2. should no submissions be received that cover the Shire's annual lease rental payment to the Department of Lands, this area be handed back to them.

As per the resolution, the lease was readvertised in the November Blarney. At the close of submissions on Friday 17 November 2017, two submissions were received:

- 1. Waterbrae Pastoral Company \$4,500.00 ex GST per year
- 2. Elmline Pty Ltd \$3,600.00 ex GST per year

On 28 November 2017, Council awarded the Lease to Waterbrae Pastoral Company and further wrote to the Department of Lands requesting that our lease payment be reviewed and reduced.

On 30 November 2017, management wrote to Waterbrae Pastoral Co advising that they were successful with their cropping submission and that a lease agreement would be forwarded in the New Year (2018).

On the 1<sup>st</sup> February 2018, advice received from the Department of Planning, Lands and Heritage advised that a review of the annual lease fee had occurred and the fee was decreased from \$5,000.00 pa to \$3,500.00 pa (ex GST), effective from 1 January 2018.

On 9 March 2018, the lease agreement for Reserve 25266 was sent to Waterbrae Pastoral Company for signing.

On Thursday 29 March 2018 the attached hand written note was received from Trevor McLean (Waterbrae) stating "I Trevor McLean am not interested in Reserve 25266 any longer".

At the 10 April 2018 Economic and Community Strategy Committee meeting the different options of persuing the lease with Waterbrae Pastoral Company through legal channels; offering the block to the next tenderer; readvertising the block or handing the block back to the Department of Planning, Lands and Heritage were all discussed.

Management did not recommend the legal option, as after reviewing the Cropping Submission documentation, it was found that there is no stated stipulation that the submission is binding and as the Lease Agreement has not been signed, the costs would far outweigh any benefit.

The next tenderer was Elmline Pty Ltd whose submission is \$100 per year above Council's rent with Department of Planning, Lands and Heritage.

If Council readvertised the block, the earliest it could award the lease would be Tuesday 22 May 2018 (unless it called a Special Meeting). It is understood that many farmers and Community Groups would have already planned and started their seeding programs so the level of response would be unknown.

Councils last option to return the block to the Department of Lands would mean a loss of \$1925.00 (\$1,750.00 + 175.00gst) as it has already paid the first rental invoice being 1 January – 30 June 2018.

#### COMMENT

It was resolved by the Economic and Community Strategy, 14 April 2018:

That the Economic and Community Strategy Committee recommend that preapproval be given to the Chief Executive Officer to liaise and offer Reserve 25266 to Elmline Pty Ltd and if taken up, ratify the lease at the 24 April 2018 Ordinary Council Meeting.

The Chief Executive Officer has spoken to Elmline Pty Ltd who have agreed to lease Reserve 25266 for \$3,600.00 ex GST per year.

#### SUMMARY

Council to consider selling a portion of Lot 41 Hunt Road Beverley to the Water Corporation.

#### BACKGROUND

As part of the Simmons Road Water Supply upgrade, the Water Corporation requires a site to establish a pumping station to supply water to the new storage tank.

Vacant land, being a portion of Lot 41 Hunt Road, has been selected by the Water Corporation as an area which would be suitable for the pumping station.

Staff met with representatives of the Water Corporation on 5 April 2018 to discuss the proposal. Previously the Water Corporation had indicated that deep sewer connection to Council's land on Hunt Road may have been possible in exchange for the portion of land they required, however this option was taken off the table by the Water Corporation with them instead looking to offer cash at the current market value of the land.

At the meeting Council staff raised some concern over potential noise pollution that may affect surrounding homes including Council's Hunt Road Village complex.

The Water Corporation could not give a definitive answer on the level of noise coming from the pumping station, but under took to design the pumps and enclosure to maximise sound reduction.

#### COMMENT

A written offer of \$25,000 and subdivision costs of 259m<sup>2</sup> from Lot 41 Hunt Road was received from the Water Corporation on 10 April 2018.

This offer seems to be fair; however the issue of future potential noise needs to be addressed.

This could possibly be achieved through the development approval process.

#### STATUTORY ENVIRONMENT

#### 3.58. Disposing of property

#### (1) In this section —

*dispose* includes to sell, lease, or otherwise dispose of, whether absolutely or not; *property* includes the whole or any part of the interest of a local government in property, but does not include money.

- (2) Except as stated in this section, a local government can only dispose of property to —
- (a) the highest bidder at public auction; or
- (b) the person who at public tender called by the local government makes what is, in the opinion of the local government, the most acceptable tender, whether or not
- it is the highest tender.
- (3) A local government can dispose of property other than under subsection (2) if, before agreeing to dispose of the property —
- (a) it gives local public notice of the proposed disposition
  - (i) describing the property concerned; and
  - (ii) giving details of the proposed disposition; and
  - (iii) inviting submissions to be made to the local government before a date to be specified in the notice, being a date not less than 2 weeks after the notice is first given; and
- (b) it considers any submissions made to it before the date specified in the notice and, if its decision is made by the council or a committee, the decision and the reasons for it are recorded in the minutes of the meeting at which the decision was made.

(4) The details of a proposed disposition that are required by subsection (3)(a)(ii) include —

- (a) the names of all other parties concerned; and
- (b) the consideration to be received by the local government for the disposition; and
- - (i) as ascertained by a valuation carried out not more than 6 months before the proposed disposition; or
  - (ii) as declared by a resolution of the local government on the basis of a valuation carried out more than 6 months before the proposed disposition that the local government believes to be a true indication of the value at the time of the proposed disposition.
- (5) This section does not apply to ----
- (a) a disposition of an interest in land under the *Land Administration Act 1997* section 189 or 190; or
- (b) a disposition of property in the course of carrying on a trading undertaking as defined in section 3.59; or
- (c) anything that the local government provides to a particular person, for a fee or otherwise, in the performance of a function that it has under any written law; or
- (d) any other disposition that is excluded by regulations from the application of this section.



# OFFER TO PURCHASE LAND FROM SHIRE FOR WATER CORPORATION PUMP STATION – LOT 41 (95) HUNT RD, BEVERLEY.

Thank you for meeting with Dominic Papalia, Shane Priddle and me on Thursday to discuss the Shire's conditions in relation to our acquisition of a pump station site at the above address. Provision of the pump station will allow the newly constructed Simmons Rd hilltop water tank to be filled and begin supplying the town's reticulated drinking water.

Whilst we understand the Shire's enthusiasm for a sewer connection to the accommodation facility on lot 41, we must re-iterate that this matter is totally separate and cannot be linked for negotiation purposes.

Water Corporation would like to make a cash offer to purchase a site of approximately 259 square metres, plan attached, to be subdivided from lot 41, documented and settled entirely at our expense. On acceptance of a written offer, we would wish to take immediate possession of the site to commence construction of the pump station.

In accordance with advertised prices for a number of central Beverley vacant land lots which are already subdivided and serviced, we believe that a fair offer for the land is \$20,000. We are making a more generous offer of \$25,000 in the hope that the Shire will view this favourably so that we can proceed in a timely manner.

We are unable at this time to provide technical details of the design noise levels which may generated when the pump is in operation. We can however assure Council that we will work with you to achieve an acceptable outcome. We would also be happy to liaise with your officers on our selection of materials and finishes for the pump station enclosure to best harmonise with the present and future surroundings of the site. We have enclosed a set of preliminary concept drawings to indicate the proposed layout of the equipment on the site. Please obtain consent on behalf of Council at your earliest opportunity, or if further information is required for this purpose, do not hesitate to contact me by phone or email.

### SUMMARY

Council to consider leasing 30B Dawson Street to Beverley Electrical Services for employee accommodation.

### BACKGROUND

Karl Smith, Director of Beverley Electrical Services, contacted Council Staff on 9 April 2018 to discuss the possibility of leasing a Council owned residential property for the purpose of housing a Beverley Electrical Services employee.

### COMMENT

Currently, the only suitable Council owned residential property available is 30B Dawson Street (2x1).

Previously, 30B Dawson Street was leased to Staff for \$150 per week.

This property is currently vacant and is currently not required to house Council staff.

Council has not entertained the option of privately leasing its residential houses in the past.

The Beverley Electrical Services enquiry represents an opportunity to utilise a Council asset, generate some return and see a new person (or persons, depending on family status) brought into the community.

If agreeable, it would be suggested that any lease agreement entered into would address the following:

- The premises be leased by Beverley Electrical Services, not an individual.
- The premises be vacated within two weeks if a need for Shire staff housing arises.
- \$250 per week be charged and all utility usage costs be paid by the Leasee.
- Lease term be for an initial period of 12 months.

- (7) When a document is produced bearing a seal purporting to be the common seal of the local government, it is to be presumed that the seal is the common seal of the local government unless the contrary is shown.

#### **Policy**

#### The Shire of Beverley's Commitment

The Shire of Beverley and its employees must take all reasonable care not to endanger the safety of themselves or others (including customers) in the workplace. Alcohol and other drug usage is an occupational safety and health issue if a worker's ability to exercise judgment, coordination, motor control, concentration and alertness at the workplace is impaired. For the purposes of this policy, the term "employee/s" shall extend to cover contractors, volunteers and any person performing work for or with the Shire of Beverley in any capacity.

#### The Individual's Responsibility

Under the Occupational Safety and Health Act 1984 (the OSH Act), workers must take reasonable care of their own safety and health and not endanger the safety and health of others at the workplace. The consumption of alcohol and/or drugs while at work is unacceptable, except in relation to any authorised and responsible use of alcohol at workplace social functions. Employees are required to present themselves for work and remain, while at work, capable of performing their work duties safely. An employee who is under the influence of alcohol and/or drugs at the workplace, or is impaired, will face disciplinary action including termination of employment.

#### **Tolerance Level**

The Shire of Beverley has a 'zero' tolerance on both Drug and Alcohol Consumption.

#### **Reporting Requirements**

Employees must report to their employer any situation where they genuinely believe that an employee may be affected by alcohol and/or other drugs.

#### **Drug Use on the Premises**

Employees who buy, take, or sell drugs on Shire of Beverley's premises, may be found to have engaged in serious misconduct. Such behaviour shall result in disciplinary action up to and including dismissal. Employees who have been prescribed medication/drugs by a medical practitioner that could interfere with their ability to safely carry out their role must inform their manager or Human Resources and disclose any side effects that these medication/drugs may cause.

#### Consumption of Alcohol on the Premises

Except in situations where the Shire of Beverley holds a function on the premises and alcohol is provided, employees must not bring in and/or consume alcohol in the workplace.

#### **Drug/Alcohol Treatment Programs**

Where an employee acknowledges that they have an alcohol or drug problem and are receiving help and treatment, the Local Government may provide assistance to the employee.

- The Local Government may allow an employee to access any accrued personal or annual leave while they are undergoing treatment. And;
- The Local Government will take steps to return an employee is to their employment position after completion of the treatment program, if practicable in the circumstances.

Where an employee acknowledges that they have an alcohol or drug problem and are receiving help and treatment, the line manager or members of senior management, will review the full circumstances and agree on a course of action to be taken. This may include redeployment to suitable alternative employment, or possible termination from employment if the employee is unable to safely carry out the requirements of their role.

#### Managers' Responsibilities - Consumption of Alcohol at Work Sponsored Functions Team managers shall:

- roam managoro onali.
- encourage their people to make alternative arrangements for transport to and from work prior to the function;
- ensure that the following is made available: Low alcohol beer, soft drinks and water Beverages: Tea, Coffee and Food;
- if the manager believes a person may be over the BAC 0.05 limit, assist the person with safe transport home (including contacting a family member or arranging a taxi); and
- if the manager has to leave the function early, appoint a delegate to oversee the rest of the function.

#### **Pre-Employment Medical Tests**

As part of the recruitment selection criteria, preferred candidates for employment positions may be required to attend a medical assessment which includes drug and alcohol testing.

#### Identification of Impairment and Testing

If the Shire of Beverley has reasonable grounds to believe that an employee is affected by drugs and/or alcohol it will take steps to address the issue.

Reasonable grounds may include (but are not limited to), where an employee's coordination appears affected, has red or bloodshot eyes or dilated pupils, smells of alcohol, acts contrary to their normal behaviour, or otherwise appears to be affected by drugs and/or alcohol.

Random testing may also be conducted. Random testing may utilise a variety of methods for randomly selecting names such as software, lottery of selection through coloured marbles in a bag drawn by each employee. All staff on site must participate in the random selection.

If the Shire of Beverley suspects that an employee is under the influence of drugs and/or alcohol it may pursue any or all of the following actions:

- direct an employee to attend a medical practitioner and submit to a medical assessment to determine whether the employee is fit to safely perform their duties;
- require that an employee undergo drug and alcohol testing administered by a representative of the Shire of Beverley; and/or
- direct an employee to go home.

A medical assessment may include a drug and/or alcohol test. Testing shall be conducted in accordance with the Australian Standard AS/NZS 4760 - Procedures for specimen collection and the detection and quantitation of drugs in oral fluid and/or the Australian Standard AS/NZS 4308 - Procedures for specimen collection and the detection and quantitation of drugs in urine.

In circumstances where an employee indicates the consumption of prescription or pharmacy drugs, the Shire of Beverley can request further information from the medical practitioner conducting the assessment about the effects and proper usage of the prescription or pharmacy drugs being taken. The Shire of Beverley may direct the employee to go home following the medical assessment until it can be established that they are fit to undertake their duties.

If an employee refuses to attend a medical examination or refuses to submit to an alcohol or drug test, the employee will be immediately directed to go home. Refusal to attend a medical assessment or refusal to go home constitutes a breach of this policy and will result in disciplinary action being taken against the employee up to and including the termination of employment.

The following steps are to be taken where an employee who has submitted to a medical assessment returns a positive test result for alcohol and/or drugs:

- The employee tested and the supervisor (or respective employer) will be informed of the result;
- A disciplinary discussion will take place in accordance with the disciplinary policies and procedures of the Shire of Beverley.

An employee who returns a positive test will be in breach of this policy. A breach of this policy will result in disciplinary action being taken against the employee up to an including the termination of employment.

#### **Education, Training & Awareness**

Employees who recognise that they have a drink or drug problem, or that they are at risk of developing one, are encouraged to come forward so that they can be assisted to the get the appropriate help.

#### **Consequences of Breaching this Policy**

An employee engaged by the Shire of Beverley who breaches the provisions of this policy will face disciplinary action including termination of employment.

#### Variation to this Policy

This policy may be cancelled or varied from time to time. All the organisation's employees will be notified of any variation to this policy by the normal correspondence method.

### SUMMARY

An application has been received from the Water Corporation to construct a Water Pumping Station on a portion of 95 (Lot 41) Hunt Road, Beverley. It will be recommended the application be approved.

### BACKGROUND

The subject site is located at 95 (Lot 41) Hunt Road, is 1.2142 ha in extent and zoned Residential R10/25. It contains the existing Hunt Road Village.

As per the attached application documentation the Water Corporation intends to construct a Water Pumping Station to feed the new Reservoir and is crucial for the functioning of the new infrastructure.

### COMMENT

The proposed Land Use of a Water Pumping Station is regarded as a 'Public Utility' Land Use in the Residential Zone, which is an 'AA' use in terms of Shire of Beverley Town Planning Scheme No. 2.

The proposed use may therefore be permitted at the discretion of Council.

The proposed Water Pumping Station will be located on a separate land parcel which will be subdivided from the parent Lot 41, which associated costs will be borne by the Water Corporation. Council's permission to progress this aspect of the proposal and to alienate the land for this purpose, is the subject of a separate Agenda Item at this meeting.

During pre-submission consultation with the Water Corporation a concern was expressed by Shire Staff as to the noise levels of the proposed facility in relation to its close proximity to the Hunt Road Village. Should Council therefore consider endorsing the Planning Officer's recommendation, it will be recommended that a condition of planning approval be imposed that will require suitable noise attenuation measures in the design, construction and operation of the proposed facility.
