

RECYCLING

The following items can be recycled:

GLASS

Clean bottles & Jars (lids removed).

PLASTIC

Empty bottles and containers with 1, 2 or 3 printed on the bottom (lids removed).

PAPER

Clean, un-tied newspapers, paper, magazines, telephone books and cartons.

ALUMINIUM & STEEL

Cans, tins, clean foil, aerosol cans.

CARDBOARD

Clean, flattened boxes and cartons.

LIQUID PAPERBOARD

Milk, juice and laundry detergent cartons.

The following items cannot be recycled

- TYRES
- POISONS
- CHEMICALS
- SOLVENTS
- ASBESTOS

Items not recyclable (as per the list above) may still be accepted into the general waste stream. Please ask the landfill attendant or contact Council's Environmental Health Officer on 9646 1200.

**BEFORE ENTERING THE
SITE, PLEASE REPORT TO
THE TIP ATTENDANT**

A revised approach to the handling of waste material being sent to landfill has been adopted by the Shire of Beverley.

With careful management, and a keen desire to reduce landfill, the site should be available for use for the next 10 – 12 years.

Council encourages all ratepayers to participate in reducing the amount of waste material sent to landfill.

The Shire is governed by the licensing conditions that are placed by the Department of Environment Regulations on the landfill site licence.

Council will consider the implementation of a transfer station once the current landfill site is no longer available.

Recycling:

The introduction of recycle bins for residential use was implemented by Council in January 2013 and is conducted on a fortnightly basis.

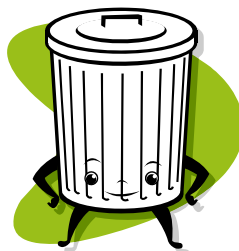
You are asked to:

1. Place your rubbish bin and your recycling bin on the kerb next to each other leaving a gap of about ½ metre between the bins.
2. Leave bins out until the truck has emptied them as the bins are NOT be emptied at the same time.
3. Not to place recycling in plastic bags.
4. Make sure recycling material is clean and jars/bottles are empty.

As an ongoing commitment from the Shire, the disposal of uncontaminated green waste and domestic quantities of asbestos (plastic wrapped) will again not incur a fee.
