SUMMARY

Council to consider awarding the Bitumen Tender RFT1/2526 for the 2025/26 bitumen works program.

BACKGROUND

Tenders were called for the supply and delivery of bitumen products and services using the WALGA E-quote system which closed on 8 September 2025. This request was sent to 6 bitumen supply companies, 5 tenders were received.

Based on price and performance, Boral would be the preferred supplier. We have used them in previous years and further consultations will be carried out to ensure application rates and monitoring is carried out after the seal is laid.

ELECTORAL CARETAKER PERIOD POLICY STATEMENT

The Officer's Recommendation has been reviewed in context of the Shire's Electoral Caretaker Period Policy. The Acting CEO has determined that this report is approved for Council's consideration due to the following factors – the need to secure a bitumen provider and confirm the Bitumen Program as a matter of urgency, the recommended tenderer is under the \$250,000 tender threshold and there is already a budget allocation made in the 2025/26 Budget for an amount greater than the Officer's Recommendation.

STATUTORY ENVIRONMENT

Local Government Act 1995:

3.57 Tenders for providing goods or services

- (1) A local government is required to invite tenders before it enters into a contract of a prescribed kind under which another person is to supply goods or services.
- (2) Regulations may make provision about tenders.

Local Government (Functions and General) Regulations 1996:

11A. Purchasing policies for local governments

- (1) A local government is to prepare or adopt, and is to implement, a purchasing policy in relation to contracts for other persons to supply goods or services where the consideration under the contract is, or is expected to be, \$250 000 or less or worth \$250 000 or less.
- (2) A purchasing policy is to make provision for and in respect of the policy to be followed by the local government for, and in respect of, entering into contracts referred to in subregulation (1).
- (3) A purchasing policy must make provision in respect of —
 - (a) the form of quotations acceptable; and
 - (ba) the minimum number of oral quotations and written quotations that must be obtained; and
 - (b) the recording and retention of written information, or documents, in respect of —
 - (i) all quotations received; and
 - (ii) all purchases made.

11. When tenders have to be publicly invited

- (1) Tenders are to be publicly invited according to the requirements of this Division before a local government enters into a contract for another person to supply goods or services if the consideration under the contract is, or is expected to be, more, or worth more, than \$250 000 unless subregulation (2) states otherwise.

15. Minimum time to be allowed for submitting tenders

- (1) If a notice under regulation 14(1) is given, the date and time referred to in regulation 14(3)(d) has to be at least 14 days after the notice is —
 - (a) published on the local government's official website; and
 - (b) published in at least 3 of the ways prescribed in the *Local Government (Administration) Regulations 1996* regulation 3A(2).
- (2) If a notice under regulation 14(2) is given to a person listed as an acceptable tenderer, the date and time referred to in regulation 14(3)(d) has to be at least 14 days after the notice is given.

16. Receiving and opening tenders, procedure for

- (1) The CEO is responsible for keeping any tender submitted including a tender submitted by facsimile or other electronic means in safe custody, and for ensuring that it remains confidential.
- (2) Tenders are not to be opened, examined, or assessed until the time after which further tenders cannot be submitted.
- (3) When tenders are opened —
 - (a) there must be present —
 - (i) at least 2 employees of the local government; or
 - (ii) one employee of the local government and at least one person authorised by the CEO to open tenders;
 - and
 - (b) members of the public are entitled to be present; and
 - (c) details of the tenders (other than the consideration sought in the tender) are to be immediately recorded in a register to be known as the tenders register.

17. Tenders register

- (1) The CEO is responsible for keeping the tenders register and making it available for public inspection.
- (1A) The CEO must publish the tenders register on the local government's official website.
- (2) The tenders register is to include, for each invitation to tender —
 - (a) a brief description of the goods or services required; and
 - ~~[(b) deleted]~~
 - (c) particulars of —
 - (i) any notice by which expressions of interests from prospective tenderers was sought; and
 - (ii) any person who submitted an expression of interest; and

(iii) any list of acceptable tenderers that was prepared under regulation 23(4);
and

(d) a copy of the notice of the invitation to tender; and

(e) the name of each tenderer whose tender has been opened; and

(f) the name of any successful tenderer.

(3) The tenders register is to include for each invitation to tender the amount of the consideration or a summary of the amount of the consideration sought in the tender accepted by the local government.

18. Rejecting and accepting tenders

(1) A tender is required to be rejected unless it is submitted at a place, and within the time, specified in the invitation for tenders.

(2) A tender that is submitted at a place, and within the time, specified in the invitation for tenders but that fails to comply with any other requirement specified in the invitation may be rejected without considering the merits of the tender.

(3) If, under regulation 23(4), the CEO has prepared a list of acceptable tenderers for the supply of goods or services, a tender submitted by a person who is not listed as an acceptable tenderer is to be rejected.

(4) Tenders that have not been rejected under subregulation (1), (2), or (3) are to be assessed by the local government by means of a written evaluation of the extent to which each tender satisfies the criteria for deciding which tender to accept and it is to decide which of them (if any) it thinks it would be most advantageous to the local government to accept.

(4a) To assist the local government in deciding which tender would be the most advantageous to it to accept, a tenderer may be requested to clarify the information provided in the tender.

(5) The local government may decline to accept any tender.

(6) If a local government has accepted a tender but acceptance of the tender does not create a contract and within 6 months of the day on which the tender was accepted the local government and the successful tenderer agree not to enter into a contract in relation to the tender, the local government may accept from the other tenders the tender which it thinks it would be most advantageous to the local government to accept.

(7) If a local government has accepted a tender and acceptance of the tender creates a contract and within 6 months of the day on which the tender was accepted the local government and the successful tenderer agree to terminate the contract, the local government may accept from the other

tenders the tender which it thinks it would be most advantageous to the local government to accept.

19. Tenderers to be notified of outcome

The CEO is to give each tenderer notice in writing containing particulars of the successful tender or advising that no tender was accepted.

SUMMARY

An application has been received to amend the location of the building envelope on 41 (Lot 204) Simmons Road, as well as development of a new Single House, associated structures and Water Tank. It will be recommended the application be approved.

BACKGROUND

The applicant is proposing to amend the location of the building envelope on the abovementioned lot and construct a new Single House, associated structures and Water Tank. The Water Tank is proposed to be located outside of the Building Envelope. Please refer to the existing building envelope plan, new site development plan and other drawings, attached hereto.

The subject property is zoned '*Rural Residential*' pursuant to the *Shire of Beverley Local Planning Scheme No. 3 (LPS3)* and is 2.04 ha in extent.

The applicant submitted written justification for the proposal, attached to this report.

COMMENT

It is considered that the proposed amended building envelope location will result in better development potential of the property as it is deemed to have less rock, better drainage and is level for construction. The proposed amendment of the location of the building envelope location is therefore supported.

The proposed Single House, associated structures & Water Tank comply with the *Shire of Beverley Local Planning Scheme No. 3* requirements and Planning Policies.

It is not considered that placement of the Water Tank outside the designated Building Envelope will have any negative impacts on the amenity of the locality and is supported. As mentioned by the applicant, the Water Tank will be clad in a Colorbond Basalt finish to blend in with the proposed dwelling. Existing landscaping will further shelter the Water Tank.

It is considered that the proposed development will be in pace with the character of the area and similar development on neighbouring lots.

ELECTORAL CARETAKER PERIOD POLICY STATEMENT

The Officer's Recommendation has been reviewed in context of the Shire's Electoral Caretaker Period Policy and the Acting CEO has determined that it does not constitute a Major Policy Decision as defined by Policy EM 009. The Acting CEO therefore approves this report for Council's consideration.

The application is to be considered under the Shire of Beverley's *Local Planning Scheme No. 3*.

OFFICER'S RECOMMENDATION

That Council grant approval for an amendment to the building envelope at 41 (Lot 204) Simmons Road, Beverley as well as approval for a Single House, associated structures and Water Tank, subject to the following conditions and advice notes:

Conditions:

1. Development shall be carried out only in accordance with the terms of the application as approved herein and any approved plan, prepared by the applicant and endorsed by Council's Shire Planner.
2. As the Water Corporation reticulated sewer is not available the premises are to be connected to an approved wastewater treatment system, which complies with the requirements of the Treatment of Sewage and Disposal of Effluent and Liquid Waste Regulations. The approved system is not to be used for disposal of industrial liquid waste or other non-ablution wastes (refer to Advice Note 5).
3. Suitable arrangements are to be made for provision of sufficient potable water for the dwelling.

Advice Notes:

- Note 1: If the development the subject of this approval is not substantially commenced within a period of 2 years, or another period specified in the approval after the date of determination, the approval will lapse and be of no further effect.
- Note 2: Where an approval has so lapsed, no development shall be carried out without the further approval of the local government having first been sought and obtained.
- Note 3: Nothing in the approval or these conditions shall excuse compliance with all relevant written laws in the commencement and carrying out of the development.
- Note 4: The applicant is advised a building permit is required prior to commencement of any building works.
- Note 5: With regard to Condition 2, an application is to be submitted to the Council's Environmental Health Section in conjunction with the Building Permit application.
- Note 6: If an applicant is aggrieved by this decision there is a right of review by the State Administrative Tribunal in accordance with the *Planning and Development Act 2005* Part 14. An application must be made within 28 days of the determination.

Dear Beverley Shire Planner

We wish to apply for Planning permission for our proposed residence at 41 Simmons rd BEVERLEY, the following items as well as the complete project are requested to be reviewed.

. Building Envelope movement

. Water tank outside the building envelope

The building envelope is proposed to move backwards from 35m to 30m from the rear(south) and the Eastern boundary from 20m to 43m,

We also wish the envelope be adjusted in width from 40m to 31.9m and length from 50m to 62.7m whilst still retaining the same size

2000m².

The Water tank is proposed to be approx 8 m wide x 2.18m high with a capacity of 130 000Litres, as marked on the plan, it will be finished in Colourbond Basalt matching our proposed dwelling. It already has natural screening of native river gums and bottlebrush shrubs to the street frontage of the block.

The above item changes will ensure our proposed dwelling fits within the building envelope including septic & leach drains, ensure our water harvest relies on gravity only and lastly ensures privacy from the road and our direct next door neighbour.

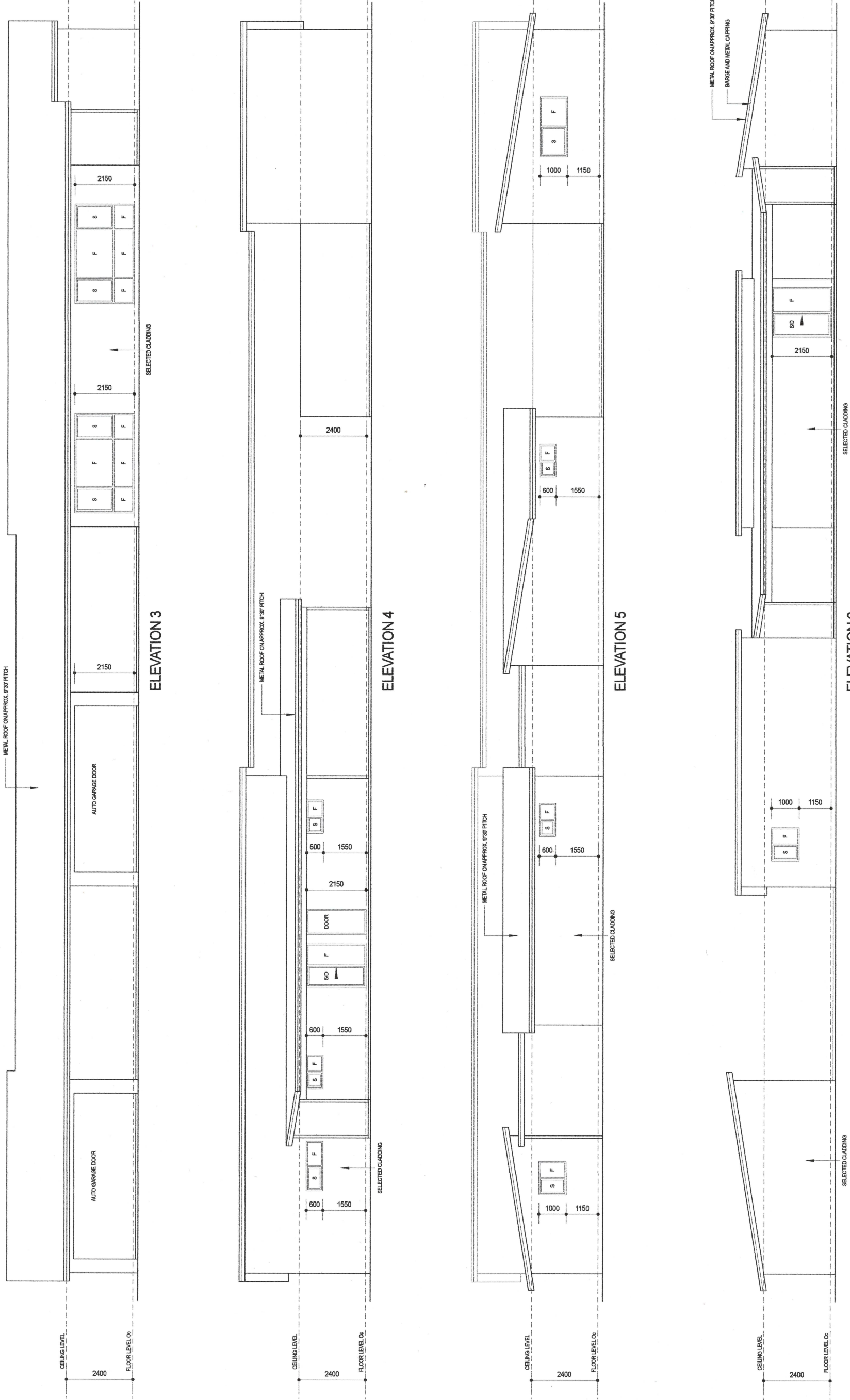

EXISTING BUILDING ENVELOPE



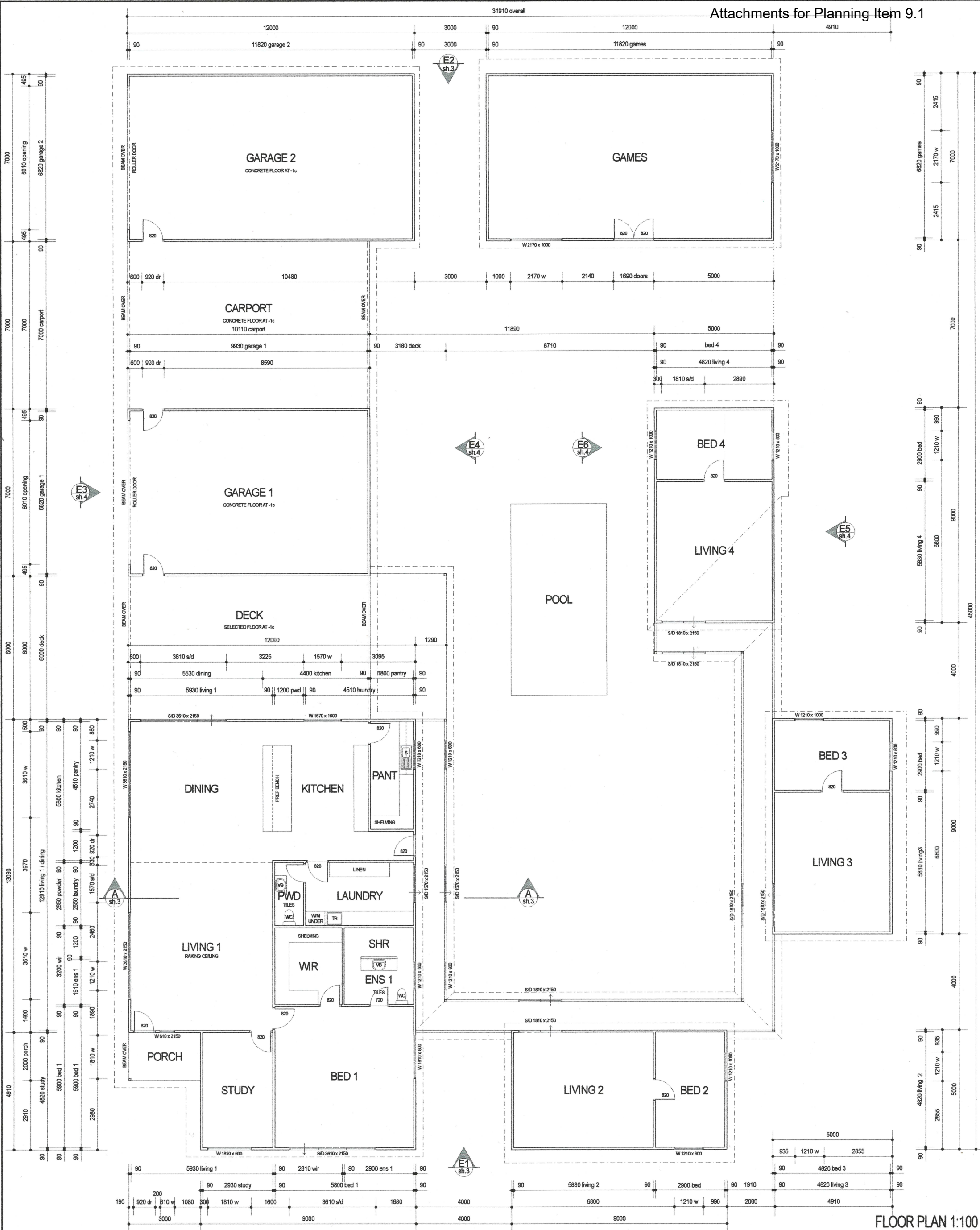

SUMMARY

Council to consider allowing the discount on Assessment 1521.

BACKGROUND

The annual rate notice issue date was 13 August 2025, the discount due date was 3 September 2025 and the due date was 17 September 2025. The ratepayer advised that he had tried to pay by BPAY on 17 September 2025 but the payment bounced back.

Rates on this property have historically been paid in the discount period with the discount being applied.

COMMENT

The ratepayer has asked for allowance of the discount due to personal issues.

"I have not been in Beverley for about two months due to personal issues, so I was unable to get my mail from the PO Box. Upon getting the notice I tried to use BPAY for the first time and thought it was all good, but have since realised it didn't go through.

I am a long term rate payer, always paying in full before the early bird due date. It is unfortunate this year that I was unable to pay in person like I usually do. I am happy to pay the discounted amount in full, which I tried to do on BPAY, and would have done over the phone or driven to Beverley to pay in person today if allowed.

I'm on a pension and cannot work, so I've saved up for the rates and adding an extra \$145 to that is literally a weeks worth of food that I have to do without.

Can you please let me know ASAP if I can pay the discounted rate in full."
