3. PUBLIC QUESTION TIME

3.1 Locking of Town Standpipes – (File Ref: WS 005)

Mr Noel Counsel expressed concern in regard to people that are connected to the mains using water from Standpipes.

The President advised that the matter was discussed at the November Council meeting and in an effort to overcome concerns with Standpipes, within the Beverley Townsite, it is Council's intention to lock these facilities from Tuesday 1 January 2008.

Mr Bob Reed also expressed great concern again in regard to the misuse of water from the Standpipes by people connected to the mains and commented that the figures in the register appear to be being altered by someone. Mr Reed felt that in particular during the holiday season that there would be more misuse of the Standpipes and commented that he felt the Standpipes ought to be locked earlier than the 1st January.

The President reiterated that a decision had been made at the November meeting but the date will not be changed as there is no time for advertising Council's intention.

3.2 Scheme Water Supply to Beverley Townsite – 100th Anniversary Celebration (File Ref: WS 001)

Mrs Morag Whitney and Mrs Peg Kempton, on behalf of the Beverley Historical Society, presented a plaque to Council with a request that it be mounted on a rock or other suitable monument on the lawn between the fountain at the side of Council's Administration Building for the purpose of commemorating the 100th Anniversary of the availability of Scheme Water in the Beverley townsite. The celebration will be held on Tuesday 5 February 2008, commencing at 2pm and the Society will invite various dignitaries and some of the school children to attend.

The President suggested that Mr Steve Vincent, Works Supervisor meet with Mrs Kempton and Mrs Whitney to discuss a suitable monument for the plaque in time for the anniversary celebration on 5 February.

3.3 Beverley Airfield/Airstrip Reserve (File Ref: BRE 32745)

Mr Ian Edwards enquired of Council as to what was being done in regard to the caravans at the Airstrip Reserve, expressing concern that they were parked in very close proximity to one another. Mr Edwards felt that the use of the Airstrip land by the Beverley Soaring Society and other aircraft could jeopardise future development in the area, as noise made by these activities affects the quality of lifestyle of nearby residents.

The President advised that use of the Airstrip Reserve by the Soaring Society was discussed at Council's November meeting. The President also advised Mr Edwards that he and the Chief Executive Officer had met with representatives from the Society to consider their use of the Airstrip Reserve into the future.

The President commented that he hoped Council would make an "in principle" decision later in the meeting, so that negotiations could be considered in regard to whether to extend the Society lease.

3.4 Langsford Street – Grading (File Ref: WO LAN)

Mr Bob Reed expressed concern that grading of Langsford Street had left the surface very slippery.

3.5 Proposed Beverley Community Centre (File Ref: CS 008)

Mr Harold Anderson brought before Council the idea of building a community centre with a kitchen. The purpose of the building would be to enable citizens to interact and perhaps undertake various hobbies. Mr Anderson suggested that this might be built on the area of land next to the Dead Finish Museum. He advised that Darkan and Mukinbudin had similar venues and added that he will be meeting with a representative of the Wheatbelt Area Consultative Committee late in January and would like two or three Councillors to attend.

The President advised that Council would discuss this matter later in the meeting.

7.2 COUNCILLOR REPORT

7.2.1 Cr Dee Ridgway – Activities for Youth (Item 6.2.1 of November Council Meeting) (File Ref: CS 006)

Lyn's Gym & Youth Liaison Officer

On Monday 3 December the Chief Executive Officer, Cr Belinda Foster and myself met with Lyn Kay to discuss youth activities in Beverley including the use of the Exhibition Shed as a Youth Centre and the recent visit of the YMCA bus. Lyn is very enthusiastic and has many ideas. It was proposed to commence a Youth Centre (in conjunction with the LDAG group) at the Exhibition Shed on a fortnightly basis commencing 28 December 2007.

I attended an LDAG meeting on Monday 10 December 2007, as an observer and whilst there were only 4 members at this meeting I found the group to be extremely enthusiastic and keen to provide activities for youth in Beverley. The age ranges of those at the meeting were around 14-17. Lyn has attended these meetings previously. This would be worthwhile as the group's youthful enthusiasm and some experienced guidance would be a good blend.

As Council is aware, the Shire has purchased the gym equipment from Lyn Kay. There is no written agreement between the parties to provide guidelines for the hire/lease/use of what is now Shire property.

I propose Council enter into an arrangement whereby Lyn continues to use the gym as she currently has been, retaining all proceeds and continuing with the nominal rental arrangement for the building and in return Lyn would provide services as a Youth Liaison Officer on behalf of the Shire for the fortnightly Friday night Youth Centre and continue to interact with the LDAG group and youth in Beverley. These arrangements to be review in 6 months.

The "Strategic Goals" for the Shire (printed Shire website) include a stated priority of "managing youth issues and needs through a youth strategy". Youth strategies/groups in Beverley appear to have been disjointed in the past. The above arrangement could be the start of a more co-ordinated approach and upon receipt of any grant moneys to fund the role of a Youth Liaison Officer other initiatives could be developed.

In addition to supporting youth, an arrangement as suggested would give Council some accountability for its property (i.e. gym equipment), security to Lyn for the gym business and hopefully appease any concerned local businesses who may view the gym as being a local business subsidised by the Shire.

In relation to the Youth Liaison Officer role I suggest Council pay the fees associated with Lyn gaining her bus licence and working with children/police clearance if not already attained. Working with children/police clearance should also be extended to a small number of people who Lyn feels she would like included as volunteer helpers for the Youth Centre.

Funds of \$3,200.00 have been allocated in the 2007/2008 budget for youth initiatives. (I note the same amount was allocated in the 2006/2007 budget but not used).

BACKGROUND

The Western Australian Planning Commission has forwarded, for Council's comments, an application for the subdivision of Lot 41 Smith Street, Beverley. The proposal is to create two lots with areas of 1919m² and 2224m². The larger lot is to have battleaxe access to Smith Street for the purpose of services.

The lot is currently zoned Residential R10.

All applications for the relocation of second-hand buildings will be assessed against this policy prior to a decision being made under the provisions of the Scheme.

In determining the application, Council may: -

Approve the application; Approve the application with conditions; or Refuse the application.

Section 5.3 states;

When giving consideration to an application for planning consent, Council shall give consideration to: -

The building in its relocated position being rendered visually acceptable by the use of verandahs, screening and/or landscaping; and

The design, scale and bulk of the proposed building being compatible with the type of buildings that exist in the locality in which it is to be located.

Section 6 requires the applicant to pay a \$5,000.00 cash bond.

COMMENT

Council has already approved another dwelling, so this application should only be a formality.

The dwelling is a timber-framed house. It can be made to comply with the new requirements of the Building Code of Australia. The asbestos will be removed in Toodyay. There will be insulation and external cladding fitted at the same time. The remaining works will be done on site.

BACKGROUND

Mr C Pepper, Proprietor of the Beverley Supermarket and Liquor has requested that Council Road be extended to enable access to the rear of Lot 124. The previous access was via a lane on Lot 123, however the owners have now closed this.

The access is needed for delivery of gas, which is stored at the rear of the premises and to enable freight to be unloaded in preference to having vehicles parked in Vincent Street.

COMMENT

The extension of Council Road would require a resumption of portion of Lot 427, which was recently purchased by the Shire of Beverley from the Crown. In preference to creating a 20 metre road reserve from a 80.9 metre frontage I would suggest an easement of say 6m – 7m be provided along the southern boundary of Lot 427 to enable access to Lot 124.

9.3.1 GENERAL – PLANT AND WORKS

9.3.1.1 Old Fire Tender

The old fire tender is now kept in a shed on Avoca Rd. The batteries will need some way of being charged, as it is possible that this truck may stand idle for long periods of time. It is recommended that Council purchase a solar panel with a regulator. The cost for this would be approximately \$300.00.
